

RESOLUTION NO. 2372-11

A RESOLUTION OF THE CITY OF OVIEDO, FLORIDA, ADOPTING A SCHEDULE FOR FEES FOR EMERGENCY MEDICAL TRANSPORT SERVICES AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City of Oviedo Fire Rescue provides Emergency Medical Advanced Life Support and Basic Life Support Services to the citizens and visitors of the City of Oviedo, and;

WHEREAS, the delivery of Emergency Medical Services including Patient Transportation Services to Central Florida Hospitals are permissible under the Certificate of Public Convenience and Necessity (COPCN) for the City of Oviedo Fire Rescue Department and in accordance with the Florida Bureau of Emergency Medical Services and;

WHEREAS, the City of Oviedo Fire Rescue Department, and in accordance with the Health Care Financing Administration are permitted to establish fees for services that offset those expenses associated with the delivery and management of an Emergency Medical Service and Patient Transportation Program and have selected a billing agency (ADPI-Intermedix) as the selected billing agent to conform to any and all forms of required legislation applied to patient billing, and:

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OVIEDO, FLORIDA, THAT:

SECTION 1: The City Council authorizes the adoption of Resolution 2372-11, adopting the following Patient Transport Fee Schedule:

Basic Life Support Non-Emg	\$400
Basic Life Support Emg	\$600
Advanced Life Support Non-Emg	\$460
Advanced Life Support (ALS 1)	\$650
Advanced Life Support (ALS 2)	\$750
Mileage (Per Mile)	\$10

SECTION 2: Conflicts. All Resolutions or parts of Resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

SECTION 3: Severability. If any Section or portion of a Section of this Resolution proves to be invalid, unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force, or effect of any other Section or part of this Resolution.


SECTION 4: Effective Date. Resolution No. 2372-11 shall become effective immediately upon its adoption.

SECTION 5: Self-pay patients, who are residents of the City of Oviedo and lack any form of health insurance, shall be afforded a discounted Patient Transport Fee reduced to the maximum allowable Medicaid rate.

SECTION 6: Balances at or below \$5.00 shall automatically be written off to facilitate a "closed" account status.

SECTION 7: The Patient Transport Fee Schedule may be adjusted only for those collectables in accordance with Medicare and/or Medicaid maximum allowable fee schedule.
