

## RESOLUTION NO. 4597-25

**A RESOLUTION OF THE CITY OF OVIEDO, FLORIDA, APPROVING A NON-EXCLUSIVE COMMERCIAL SOLID WASTE FRANCHISE AGREEMENT WITH COASTAL WASTE AND RECYCLING, INC.; AUTHORIZING THE MAYOR TO EXECUTE SAID AGREEMENT; PROVIDING FOR IMPLEMENTING ADMINISTRATIVE ACTIONS, SCRIVENER'S ERRORS, CONFLICTS, SEVERABILITY, AND EFFECTIVE DATE.**

**WHEREAS**, Section 38-92 of the *Code of Ordinances of the City of Oviedo, Florida* authorizes the City to contract with private waste collectors for the collection and disposal of solid waste from designated areas and premises within the City of Oviedo; and

**WHEREAS**, Section 38-95 of the *Code of Ordinances of the City of Oviedo, Florida* states "All private waste collectors desiring to provide service for designated areas and premises with the City shall, prior to contracting with any person within the designated areas or any person in charge of designated premises, enter into an agreement with the City in accordance with the terms and conditions as set forth in this article"; and

**WHEREAS**, Section 38-97 of the *Code of Ordinances of the City of Oviedo, Florida* states "No private waste collectors shall engage in collection of solid waste within the City until authorized to do so by the City pursuant to written agreement. Such agreement shall be approved by resolution of the City Council"; and

**WHEREAS**, the mechanism for such contract is a Non-Exclusive Commercial Solid Waste Franchise Agreement which may be entered into with the City of Oviedo; and

**WHEREAS**, the Non-Exclusive Franchise Agreement for the collection of commercial solid waste provided in Exhibit 1 will allow Coastal Waste and Recycling, Inc. to provide commercial solid waste removal services to the businesses located in the City of Oviedo

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OVIEDO, FLORIDA, AS FOLLOWS:**

**SECTION 1.** Approval of Non-Exclusive Commercial Solid Waste Franchise Agreement. The City Council hereby approves a Non-Exclusive Commercial Solid Waste Franchise Agreement with Coastal Waste and Recycling, Inc. provided in the Exhibit 1.

**SECTION 2.** Authorization to Execute Non-Exclusive Commercial Solid Waste Agreements. The City Council hereby authorizes the Mayor to execute the Non-Exclusive Commercial Solid Waste Franchise Agreement provided in Exhibit 1.

**SECTION 3.** Implementing Administrative Actions. The City Manager is hereby authorized and directed to take such actions as he may deem necessary and appropriate in order to implement the provisions of this Resolution. The City Manager may, as deemed appropriate,

necessary and convenient, delegate the powers of implementation as herein set forth to such City employees as deemed effectual and prudent.

**SECTION 4.** Scrivener's Errors. Typographical errors and other matters of a similar nature that do not affect the intent of this Resolution, as determined by the City Clerk and City Attorney, may be corrected.

**SECTION 5.** Conflicts. All Resolutions or parts of Resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

**SECTION 6.** Severability. If any Section or portion of a Section of this Resolution proves to be invalid, unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force, or effect of any other Section or part of this Resolution.

**SECTION 7.** Effective Date. This Resolution shall become effective immediately upon its passage and adoption.
