

## **RESOLUTION NO. 4610-25**

### **A RESOLUTION OF THE CITY OF OVIEDO, FLORIDA, APPROVING A CALL TO ARTIST FOR THE OVIEDO ARTS AND ENTERTAINMENT DISTRICT LOGO; AND PROVIDING FOR IMPLEMENTING ADMINISTRATIVE ACTIONS, SCRIVENER'S ERRORS, CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.**

**WHEREAS**, at its April 28, 2025, work session, the City of Oviedo City Council directed Staff to coordinate with the Public Arts Board to create a logo to represent the Oviedo Arts and Entertainment District; and

**WHEREAS**, the logo will be featured on white plastic reusable beverage cups containing sixteen (16) ounces with no handle, commonly known as a stadium cup, to recognize the approved cup within the Oviedo Arts and Entertainment District; and

**WHEREAS**, the final design of the Oviedo Arts and Entertainment District logo will be reflected in the Code of Ordinances Section 2-12; and

**WHEREAS**, at its May 7, 2025, meeting, the Public Arts Board voted to propose a Call to Artist for a Logo Design representing the Oviedo Arts and Entertainment District; and

**WHEREAS**, the details of the Call to Artist for the Oviedo Arts and Entertainment District Logo are provided in Exhibit 1; and

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OVIEDO, FLORIDA, AS FOLLOWS:**

**SECTION 1.** Approval of a Call to Artist for the Oviedo Arts and Entertainment District logo. The City Council approves a Call to Artist for the Oviedo Arts and Entertainment District logo in accordance with Exhibit 1.

**SECTION 2.** Implementing Administrative Actions. The City Manager is hereby authorized and directed to take such actions as he may deem necessary and appropriate in order to implement the provisions of this Resolution. The City Manager may, as deemed appropriate, necessary and convenient, delegate the powers of implementation as herein set forth to such City employees as deemed effectual and prudent.

**SECTION 3.** Scrivener's Errors. Typographical errors and other matters of a similar nature that do not affect the intent of this Resolution, as determined by the City Clerk and City Attorney may be corrected.

**SECTION 4.** Conflicts. All Resolutions or parts of Resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

**SECTION 5.** Severability. If any Section or portion of a Section of this Resolution proves to be invalid, unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force, or effect of any other Section or part of this Resolution.

**SECTION 6.** Effective Date. This Resolution shall become effective immediately upon its passage and adoption.
