City Manager Bryan Cobb provided background and Mayor Sladek described the pledge process. Council consensus was to use the City’s media outlets to promote the pledge.

CITY MANAGER'S REPORT

City Manager Bryan Cobb stated the CALNO bylaws require a designated alternate and requested Council appoint one. Council consensus was to appoint Council Member Britton as the designated alternate.

COMMUNICATIONS AND REPORTS

Council Member Keith Britton

Council Member Britton advised he received an email from Florida League of Cities sent an email asking for people to sign up to be on the Legislative Policy Committees.

Deputy Mayor Bob Pollack

Council Member Pollack stated that Taste of Oviedo was well attended and asked if the City can start planning for future events. Recreation and Parks Director Dru Boulware advised on possible future City events. Council Member Pollack requested and received consensus to have a proclamation for Florida Climate Week on the April 19th Council meeting agenda. Council discussed the State of the City and there was consensus to postpone it this year. Council Member Pollack requested an update on what was submitted to State Representative Stephanie Murphy's office and Assistant City Manager Patrick Kelly provided an update.

Council Member Jeff Boddiford

Council Member Boddiford stated that on March 5th the Police Foundation Golf Tournament raised \$125,000 and that it was a great event. He commented that on March 6th the Hope's Sham Rock N' Run 5k had about 500 runners. He stated that Oviedo was voted the 6th safest City in Florida and gave a hats off to Police, Fire, Public Works and the Recreation and Parks Departments for playing a part in that. Council Member Boddiford requested and received an update from Police Chief Dale Coleman on a Special Needs registry. He commented that on April 30th is the Relay for Life event at Twin Rivers and thanked Pastor Mercer for the presentation of the Bible.

Council Member Judith Dolores Smith

Council Member Smith commented that on April 15th the Oviedo American Legion is hosting a meeting recognizing the Oviedo Fire and Police Departments. She stated that on April 2nd as part of the Leadership Seminole Class she witnessed the Seminole County Boot Camp for Fire and Rescue personnel and that she appreciated all their hard work and dedication. Council Member Smith spoke about her experience attending the funeral of Tampa Master Police Officer Jesse Madsen.

Mayor Megan Sladek

Mayor Sladek requested an update on the reopening of the sidewalk on Franklin St. She stated that Cross Life Church hosted an Easter event and a farmers market and was glad to see events the public could attend. Assistant Public Works Director Alexis Stewart commented that the sidewalk on Franklin St. was closed due to construction at Solary Park and will provide a reopening schedule and alternate walking routes. Mayor Sladek requested, but did not received, consensus to have City Manager Bryan Cobb make a budget adjustment and accept \$50,000 for Florida native plants at Solary Park and Friendship Park, as well, as the athletic

program already budgeted for at Round Lake Park. Council discussed the determination made at the March 29, 2021, Work Session regarding the approved Resolution submitted to the Conference of Mayors not matching the grant application.
