## RESOLUTION NO. 4062-21

A RESOLUTION OF THE CITY OF OVIEDO, FLORIDA, AWARDING BID NO. 21-05 FOR THE PURCHASE OF A SEWER PIPE INSPECTION SYSTEM TO PAT'S PUMP & BLOWER, LLC; APPROVING AN EXPENDITURE IN THE AMOUNT OF \$154,168; APPROVING A BUDGET AMENDMENT; AND PROVIDING FOR IMPLEMENTING ADMINISTRATIVE ACTIONS, SCRIVENER'S ERRORS, CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, the City's sewer system contains 490,621 linear feet of gravity sewer main, 200,256 linear feet of force main, 2,356 manholes, and 70 lift stations, all of which are routinely inspected and maintained by the City's Public Works Utilities Division; and

**WHEREAS**, a reliable Sewer Pipe Inspection System is required to effectively maintain the system, including the ability to identify leaks, line breaks, cracks or system infiltration and is also needed for locating abandoned laterals and identifying tie-in locations for contractors engaged in new construction; and

WHEREAS, when problems such as leaks, line breaks, cracks or infiltration, occur within the sewer pipe system, staff has experienced difficulty in locating and identifying the source of the problem due to an outdated and obsolete camera system; and

WHEREAS, the camera system currently in use is old and obsolete; and

**WHEREAS**, on February 7, 2021, the City broadcasted Invitation to Bid (ITB) No. 21-05 for Sewer Pipe Inspection System; and

WHEREAS, a total of four (4) responses were received on the bid opening date of March 10, 2021 with two (2) of the responses being a "no Bid"; and

WHEREAS, Pat's Pump & Blower , LLC's bid in the amount of \$154,168 was the lowest bid received; and

**WHEREAS,** staff recommends awarding ITB No. 21-05 to Pat's Pump & Blower, LLC in the amount of \$154,168 as provided in the Bid attached as Exhibit 1; and

WHEREAS, a budget amendment is included as Exhibit 2 to transfer the budget from the Renewal and Replacement Fund (Fund 406), to the Vehicle Replacement Fund (Fund 407).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OVIEDO, FLORIDA, AS FOLLOWS:

**SECTION 1.** Award of Bid. The City Council hereby awards ITB No. 21-05 for the purchase of a Sewer Pipe Inspection System to Pat's Pump & Blower, LLC in the amount of \$154,168.

**SECTION 2.** Approving Expenditure. The City Council hereby approves the expenditure in the amount of \$154,168 for the purchase and delivery of the Sewer Pipe Inspection System.

**SECTION 3.** Approval of a budget amendment. The City Council hereby approves the budget amendment in Exhibit 2.

**SECTION 4.** Implementing Administrative Actions. The City Manager is hereby authorized and directed to take such actions as he may deem necessary and appropriate in order to implement the provisions of this Resolution. The City Manager may, as deemed appropriate, necessary and convenient, delegate the powers of implementation as herein set forth to such City employees as deemed effectual and prudent.

**SECTION 5**. <u>Scrivener's Errors</u>. Typographical errors and other matters of a similar nature that do not affect the intent of this Resolution, as determined by the City Clerk and City Attorney, may be corrected.

**SECTION 6.** Conflicts. All Resolutions or parts of Resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

**SECTION 7.** <u>Severability</u>. If any Section or portion of a Section of this Resolution proves to be invalid, unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force, or effect of any other Section or part of this Resolution.

**SECTION 8.** Effective Date. This Resolution shall become effective immediately upon its passage and adoption.
