## **RESOLUTION NO. 4063-21**

## A RESOLUTION OF THE CITY OF OVIEDO, FLORIDA, APPROVING THE PURCHASE OF TWO (2) NEW REPLACEMENT VEHICLES IN THE TOTAL AMOUNT OF \$68,334 TO REPLACE TWO (2) VEHICLES WHICH WERE DECLARED A TOTAL LOSS BY THE INSURANCE COMPANY; APPROVING A BUDGET AMENDMENT; AND PROVIDING FOR IMPLEMENTING ADMINISTRATIVE ACTIONS, SCRIVENER'S ERRORS, CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, in February 2021, City staff was involved in two separate traffic accidents involving a 2017 Ford F-150 assigned to the City's Water Plant and, a 2015 Dodge Charger assigned to the Police Department; and

WHEREAS, both vehicles involved were deemed total losses by the City's insurance company; and

WHEREAS, the City collected \$20,329.33 from the insurance company for the 2017 Ford F-150 and \$3,251.83 for the 2015 Dodge Charger; and

**WHEREAS**, staff desires to utilize the proceeds from the insurance company to purchase the two (2) new 2021 replacement vehicles; and

**WHEREAS**, the quote for a replacement 2021 Ford F-150 from Duval Ford via the Florida Sheriff's Association Bid in the amount of \$31,292 is provided in Exhibit 1; and

**WHEREAS**, the quote for a replacement 2021 Dodge Charger from Garber Dodge/Chrysler via the Florida Sheriff's Association Bid in the amount of \$26,842 is provided in Exhibit 2; and

**WHEREAS**, additional lighting and equipment for the police vehicle and decals and tag and title for both vehicles is estimated to cost an additional \$10,200; and

WHEREAS, the cost, including all equipment for both vehicles totals \$68,334; and

WHEREAS, a budget amendment is provided in Exhibit 3 to recognize the insurance proceeds received towards the Ford F-150; and

**WHEREAS**, City Council approval is required for expenditures in excess of \$50,000 as provided in the City's Purchasing Policy.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OVIEDO, FLORIDA, AS FOLLOWS:

**SECTION 1.** <u>Approving the purchase of two (2) new vehicles.</u> The City Council hereby approves the purchase of two (2) new vehicles from the Florida Sheriff's Association bid, a Ford

F-150 as provided in Exhibit 1, and a Dodge Charger as provided in Exhibit 2, as well as all lighting, equipment, decals and tag and title in the amount of \$68,334.

**SECTION 2**. <u>Approval a Budget Amendment.</u> The City Council hereby approves the budget amendment as provided in Exhibit 3.

**SECTION 3.** <u>Implementing Administrative Actions.</u> The City Manager is hereby authorized and directed to take such actions as he may deem necessary and appropriate in order to implement the provisions of this Resolution. The City Manager may, as deemed appropriate, necessary and convenient, delegate the powers of implementation as herein set forth to such City employees as deemed effectual and prudent.

**SECTION 4**. <u>Scrivener's Errors</u>. Typographical errors and other matters of a similar nature that do not affect the intent of this Resolution, as determined by the City Clerk and City Attorney, may be corrected.

**SECTION 5.** <u>Conflicts</u>. All Resolutions or parts of Resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

**SECTION 6.** <u>Severability</u>. If any Section or portion of a Section of this Resolution proves to be invalid, unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force, or effect of any other Section or part of this Resolution.

**SECTION 7.** <u>Effective Date</u>. This Resolution shall become effective immediately upon its passage and adoption.
