

RESOLUTION NO. 4351-23

A RESOLUTION OF THE CITY OF OVIEDO, FLORIDA, ACCEPTING A STATE OF FLORIDA DEPARTMENT OF FINANCIAL SERVICES DIVISION OF STATE FIRE MARSHALL GRANT FOR HIGH-WATER RESCUE/WILDLAND FIRE APPARATUS IN THE AMOUNT OF \$275,000; APPOINTING THE FIRE CHIEF TO SERVE AS CONTRACT MANAGER FOR SAID GRANT; AUTHORIZING THE FIRE CHIEF TO EXECUTE DOCUMENTS REQUIRING THE CONTRACT MANAGER'S SIGNATURE; APPROVING A BUDGET AMENDMENT; AND PROVIDING FOR IMPLEMENTING ADMINISTRATIVE ACTIONS, SCRIVENER'S ERRORS, CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, on June 26, 2023, the City of Oviedo ("City") was notified by the State Fire Marshals Office that the City was awarded \$275,000.00 in grant funding for the purchase of a High-Water Rescue/Wildland Fire Apparatus ("Apparatus"); and

WHEREAS, the Apparatus will allow for the Oviedo Fire Department to enhance the level of service by being able to perform high-water rescue operations and also combat wildland fires within our community and neighboring jurisdictions; and

WHEREAS, the City currently does not have the aforementioned capabilities; and

WHEREAS, due to pricing increases since the inception of the most recent legislative session, the price of the Apparatus has increased by \$11,130.00, resulting in a total Project Cost of \$286,130.00; and

WHEREAS, the additional \$11,130.00 required to complete the purchase of the Apparatus can be funded by Fund Balance; and

WHEREAS, a budget amendment is provided in Exhibit 1 to recognize the \$275,000.00 from the State of Florida and approve \$11,130.00 of Fund Balance necessary to complete the purchase of the new Apparatus.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OVIEDO, FLORIDA, AS FOLLOWS:

SECTION 1. Acceptance of State of Florida Department of Financial Services Grant. The City Council hereby accepts the Florida Department of Financial Services Division of State Fire Marshall Grant for \$275,000.00 for the purchase of a High-Water Rescue/Wildland Fire Apparatus provided in Exhibit 1.

SECTION 2. Appointment of Contract Manager. The City Council hereby appoints the Fire Chief to serve as Contract Manager for the Florida Department of Financial Services Division of State Fire Marshall Grant provided in Exhibit 1 and authorizes the Fire Chief to execute any documents requiring the Contract Manager's signature.

SECTION 3. Approval of a Budget Amendment. The City Council hereby approves the budget amendment provided in Exhibit 2 for the purchase of a High-Water Rescue/Wildland Fire Apparatus.

SECTION 3. Implementing Administrative Actions. The City Manager is hereby authorized and directed to take such actions as may be deemed necessary and appropriate to implement the provisions of this Resolution. The City Manager may, as deemed appropriate, necessary and convenient, delegate the powers of implementation as herein set forth to such City employees as deemed effectual and prudent.

SECTION 4. Scrivener's Errors. Typographical errors and other matters of a similar nature that do not affect the intent of this Resolution, as determined by the City Clerk and City Attorney, may be corrected.

SECTION 5. Conflicts. All Resolutions or parts of Resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

SECTION 6. Severability. If any Section or portion of a Section of this Resolution proves to be invalid, unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force, or effect of any other Section or part of this Resolution.

SECTION 7. Effective Date. This Resolution shall become effective immediately upon its passage and adoption.
