

RESOLUTION NO. 4348-23

A RESOLUTION OF THE CITY OF OVIEDO, FLORIDA, AWARDED BID NO. ITB 23-51 TO UNIVERSAL CONTRACTING AND CONSTRUCTION INC., IN THE AMOUNT OF \$171,292.01; APPROVING A CONSTRUCTION AGREEMENT WITH UNIVERSAL CONTRACTING AND CONSTRUCTION, INC.; AUTHORIZING THE MAYOR TO EXECUTE SAID CONSTRUCTION AGREEMENT; APPROVING A BUDGET AMENDMENT; AND PROVIDING FOR IMPLEMENTING ACTIONS, SCHRIVENER'S ERRORS, CONFLICTS, SEVERABILITY, AND EFFECTIVE DATE.

WHEREAS, McKinnon Avenue is a road within the Alafaya Woods Subdivision in Oviedo;
and

WHEREAS, the McKinnon Avenue roadway, twin 36-inch reinforced concrete pipe (RCP) culverts, and the outfall ditch (aka Gould Place Ditch Outfall) were damaged during Hurricane Ian and need to be repaired; and

WHEREAS, staff advertised a bid for the interim repair work on Vendorlink on June 7, 2023, as part of ITB #23-51; and

WHEREAS, six (6) sealed bids were received and opened on June 22, 2023; and

WHEREAS, Universal Contracting and Construction Inc's bid in the amount of \$171,292.01 was the lowest and most responsive bid received for Bid No. ITB 23-51; and

WHEREAS, Staff recommends awarding Bid No. ITB 23-51 to Universal Contracting and Construction Inc.; and

WHEREAS, an additional ten percent (10%) contingency in the amount of \$17,129 will be included in the project budget; and

WHEREAS, a budget amendment is necessary to fund the total project cost of \$188,421.00 with the Use of Fund Balance in the Stormwater Fund; and

WHEREAS, the City will be requesting reimbursement from the Federal Emergency Management Agency for this project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OVIEDO, FLORIDA, AS FOLLOWS:

SECTION 1. Approval of Bid Award. The City Council hereby awards Bid No. ITB-23-51 to Universal Contracting and Construction Inc. in the amount of \$171,292.01 who is the lowest, responsive bidder per the Bid Form provided in Exhibit 1.

SECTION 2. Approval of Construction Agreement. The City Council approves the Construction Agreement with Universal Contracting and Construction provided in Exhibit 2.

SECTION 3. Authorization to Execute Agreement. The City Council hereby authorizes the Mayor to execute the Construction Agreement with Universal Contracting and Construction Inc. provided in Exhibit 2.

SECTION 4. Approval of Budget Amendment. The City Council approves the Budget Amendment provided in Exhibit 3.

SECTION 5. Implementing Administrative Actions. The City Manager is hereby authorized and directed to take such actions as may be deemed necessary and appropriate in order to implement the provisions of this Resolution. The City Manager may, as deemed appropriate, necessary and convenient, delegate the powers of implementation as herein set forth to such City employees as deemed effectual and prudent.

SECTION 6. Scrivener's Errors. Typographical errors and other matters of a similar nature that do not affect the intent of this Resolution, as determined by the City Clerk and City Attorney, may be corrected.

SECTION 7. Conflicts. All Resolutions or parts of Resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

SECTION 8. Severability. If any Section or portion of a Section of this Resolution proves to be invalid, unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force, or effect of any other Section or part of this Resolution.

SECTION 9. Effective Date. This Resolution shall become effective immediately upon its passage and adoption.
