

**RESOLUTION NO. 4359-23**

**A RESOLUTION OF THE CITY OF OVIEDO, FLORIDA, APPROVING A WATERCOLOR ILLUSTRATIVE MAP DESIGN FOR THE CITY BY MS. CARYN DAHM; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH MS. DAHM; APPROVING A BUDGET AMENDMENT; AND PROVIDING FOR IMPLEMENTING ADMINISTRATIVE ACTIONS, CONFLICTS, SCRIVENERS ERRORS, SEVERABILITY AND AN EFFECTIVE DATE**

**WHEREAS**, on April 12, 2023, the Public Arts Board recommended approval of a watercolor map to be designed by Ms. Caryn Dahm illustrating significant landmarks in the City; and

**WHEREAS**, the watercolor map will display important City landmarks, for a maximum of twenty-five (25) small location illustrations to be determined by Staff, City Council and the Public Arts Board members; and

**WHEREAS**, the original 16" by 20" watercolor map will be displayed in City Hall and a digital copy will be displayed in the City's website; and

**WHEREAS**, the City may in the future also approve postcards or merchandise displaying the design, or copies of the map displayed in City Parks since the City will own the final watercolor design; and

**WHEREAS**, the proposed cost for the watercolor map, including supplies, digitization, three (3) rounds of edits and the addition of typography is \$4,800; and

**WHEREAS**, a budget amendment is provided as Exhibit 1 transferring \$4,800 from Public Art Fund Fund Balance account to Public Art Fund Professional Services account; and

**WHEREAS**, the City and Ms. Caryn Dahm will need to enter into a professional services agreement to establish terms including, but not limited to, that the artist will grant the City the right to utilize and dispose of the selected artwork; the payment of a stipend of \$4,800 (with a \$2,400 deposit at the time of the agreement execution), and the time frame for the project execution.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OVIEDO, FLORIDA, AS FOLLOWS:**

**SECTION 1.** Approval of the Watercolor Illustrative Map. The City Council approves the watercolor illustrative map by Ms. Caryn Dahm as recommended by the Public Art Board.

**SECTION 2.** Authorization to Negotiate and Execute an Agreement with Ms. Caryn Dahm. The City Council authorizes the City Manager to negotiate and execute an agreement with Ms.

Caryn Dahm to establish the terms, including but not limited to, the artist granting the City the right to utilize and dispose of the selected artwork, the payment of a stipend of \$4,800 to the artist, and the time frame for the project execution.

**SECTION 3.** Approval of a Budget Amendment. The City Council approves the budget amendment as provided in Exhibit 1.

**SECTION 4.** Implementing Administrative Actions. The City Manager is hereby authorized and directed to take such actions as may be deemed necessary and appropriate in order to implement the provisions of this Resolution. The City Manager may, as deemed appropriate, necessary and convenient, delegate the powers of implementation as herein set forth to such City employees as deemed effectual and prudent.

**SECTION 5.** Scrivener's Errors. Typographical errors and other matters of a similar nature that do not affect the intent of this Resolution, as determined by the City Clerk and City Attorney may be corrected.

**SECTION 6.** Conflicts. All Resolutions or parts of Resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

**SECTION 7.** Severability. If any Section or portion of a Section of this Resolution proves to be invalid, unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force, or effect of any other Section or part of this Resolution.

**SECTION 8.** Effective Date. This Resolution shall become effective immediately upon its passage and adoption.
