RESOLUTION NO. 4031-21

A RESOLUTION OF THE CITY OF OVIEDO, FLORIDA, APPROVING A WORK ORDER IN THE AMOUNT OF \$66,104 FOR THE PURCHASE OF A NEW GENERATOR FROM TRADEWINDS POWER CORP. VIA THE FLORIDA SHERIFFS ASSOCIATION BID; AUTHORIZING THE MAYOR TO SIGN SAID WORK ORDER; PROVIDING FOR IMPLEMENTING ADMINISTRATIVE ACTIONS, SCRIVENER'S ERRORS, CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, maintaining the City's lift-stations to prevent sewer backups is essential to the health, safety and welfare of the community; and

WHEREAS, during power-outages, staff relies on the use of by-pass pumps and emergency generators to keep lift stations operational for City residents; and

WHEREAS, due to the excessive power outages in the area north of Panther Street, a permanently mounted backup generator is needed for Lift Station No. 28 which services both the Preserve at Lake Charm and Retreat at Lake Charm developments; and

WHEREAS, the Florida Sheriffs Association Bid identifies Tradewinds Power Corporation as the low bidder for Central Florida at a cost of \$66,104 as provided in the Work Order attached as Exhibit 1; and

WHEREAS, City Council approval is required for all purchases greater than \$50,000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OVIEDO, FLORIDA, AS FOLLOWS:

- **SECTION 1.** Approval of Work Order. The City Council approves the Work Order with Tradewinds Power Corp. in the amount of \$66,104 for the purchase of a new generator for Lift Station No. 28 via the Florida Sheriffs Association Bid provided in Exhibit 1.
- **SECTION 2.** Authorization to Execute Work Order. The City Council hereby authorizes the Mayor to execute said Work Order provided in Exhibit 1.
- **SECTION 3.** Implementing Administrative Actions. The City Manager is hereby authorized and directed to take such actions as he may deem necessary and appropriate in order to implement the provisions of this Resolution. The City Manager may, as deemed appropriate, necessary and convenient, delegate the powers of implementation as herein set forth to such City employees as deemed effectual and prudent.
- **SECTION 4.** <u>Scrivener's Errors</u>. Typographical errors and other matters of a similar nature that do not affect the intent of this Resolution, as determined by the City Clerk and City Attorney, may be corrected.

SECTION 5. <u>Conflicts</u>. All Resolutions or parts of Resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

SECTION 6. Severability. If any Section or portion of a Section of this Resolution proves to be invalid, unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force, or effect of any other Section or part of this Resolution.

SECTION 7. <u>Effective Date</u>. This Resolution shall become effective immediately upon its passage and adoption.
